
#### How was your overall experience working with Treasury?

## **PROJECTS UPDATE**

Treasury Metals continues to work on advancing the development of the Goliath Gold Complex, which includes three distinct properties: the Goliath Gold Project, Goldlund Mine (a past-producing mine) and Miller deposit. The Goliath Gold Complex includes constructing, operating, decommissioning, and remediating open-pit and underground gold mines and associated milling infrastructure, including a tailings storage facility.


## What's next for the Goliath Gold Complex?

Treasury Metals continues to advance its baseline environmental studies to refine its understanding of how the Goliath Gold Complex will interact with surrounding environment. This data will inform the development of our approaches to environmental management programs and procedures, monitoring, permitting applications, and regulatory reporting.

Technical and field studies to support engineering for the Feasibility Study and permit applications have begun and will continue throughout the year.

### What is a Feasibility Study?

A Feasibility Study is an in-depth analysis of the viability of a project, building and expanding on topics and aspects covered during a Prefeasibility Study. They are meant to be more accurate and require additional resources and studies to be



conducted successfully. These studies are intended to evaluate if a mineral reserve can be mined efficiently, profitably and sustainability. Detailed mining feasibility studies are used as a basis to estimate the project's capital cost, operating costs and overall economic viability.

We will provide updates on our progress as we advance the Goliath Gold Complex in future editions of this newsletter.
